

## READY TO SAVE MONEY AND REDUCE ENERGY CONSUMPTION? HERE'S HOW:

Only approved equipment is eligible for energy efficiency rebates. After purchasing and installing qualifying equipment, please follow these simple instructions:

1. The LED lighting purchaser must be an electric customer of Maquoketa Municipal Electric Utility.
2. The LED lighting must be Energy Star® qualified or be on the Department of Energy qualified product list. Decorative light strings, rope lighting, and non-Energy Star qualified bulbs are not eligible for this rebate. For a list of qualified LED lighting options, visit [www.energystar.gov](http://www.energystar.gov).
3. This rebate application must be turned in within 60 days of the receipt/invoice date with product cutouts (portion of packaging) for each item. Product cutouts must confirm product type, brand, model number, and Energy Star qualification. Rebate per lamp/bulb shall be 50% of the purchase price with a maximum rebate of \$20 per lamp/bulb.
4. Maximum total rebate per household shall be \$200 per calendar year.
5. The sales receipt must accompany the rebate form.

**Please allow 6-8 weeks for payment.** Missing information may delay processing.

All rebates will be in the form of bill credits.
